

PRIVACY POLICY (CAREER)

This privacy policy ("Career Privacy Policy") allows you to learn more about the origin and use of the information that is collected when:

- you apply for a job on the Relais & Châteaux Association ("Relais & Châteaux") career website;
- you apply for a job on one of the dedicated recruitment websites integrating the shared Relais & Châteaux recruitment platform and used by one of our Relais & Châteaux member hotels and/or restaurants ("Properties").

It is adopted in compliance with the French and European regulations applicable to the protection of Personal Data.

We reserve the right to amend this Career Privacy Policy at any time and recommend that you consult it regularly and at least every time you log on to the Relais & Châteaux career website or one of the Properties' dedicated websites.

1. DEFINITIONS

Capitalised terms and expressions, whether in the singular or plural form, are defined either when first used in this Career Privacy Policy or in Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation "GDPR").

2. DATA CONTROLLER IDENTITY AND SHARING OF YOUR PERSONAL DATA

In order to facilitate job-seeking for applicants who would like to join their universe, Relais & Châteaux, its subsidiaries (including Relais & Châteaux Entreprise) and the Properties have decided to offer applicants a global recruitment service that they manage jointly. In this context, when you submit your application for a particular position, unless you object, your application may be shared with one or more other Relais & Chateaux entities if your application appears likely to be of interest

to them. In addition, if you submit an unsolicited application on the Relais & Châteaux shared career website, it will be included in the Relais & Châteaux applications pool, unless you object.

Your Personal Data are therefore Processed jointly by the Relais & Chateaux Association whose registered office is at 58-60 rue de Prony, 75017 Paris, the Properties listed with their contact details at https://www.relaischateaux.com/fr/site-map/etablissements, and the companies in the Relais & Châteaux group whose contact details are:

(hereinafter collectively referred to as the "Joint Controllers").

The Joint Controllers have defined their respective obligations in this context by way of agreement, in accordance with Article 26 of the GDPR.

In broad terms, this agreement provides that Relais & Châteaux plays a coordinating role in defining the main purposes and means of Processing, the retention periods and applicable security measures. With regard to the exercise of your rights in accordance with Article 6 below, you may submit your requests to Relais & Châteaux and, if necessary, to each Joint Controller with which you may have been in contact, it being specified that, for greater simplicity, Relais & Châteaux allows you to send your requests relating to the exercise of your rights to it (see Article 6 below) and will forward them, when necessary, to the Joint Controller(s) concerned. Relais & Châteaux shall be solely responsible for updating your Personal Data on the joint tools.

Your Personal Data collected are intended for use by the Joint Controllers concerned or those likely to be interested in your application.

Some of your Personal Data may also be sent to third parties who may use them for their own purposes, particularly for the purposes of managing a dispute, such as lawyers, bailiffs, etc. Similarly, in the event that a Property or any of the companies in the Relais & Châteaux group, or all or part of their assets, are acquired by a third party, your Personal Data may be made accessible to any person involved in the preparation and completion of the transaction and included in the assets transferred.

Your Personal Data will also be made accessible to our technical service providers ("Processors" as defined by the regulations), strictly for the needs of their mission; the latter are not authorised to use them for their own account.

3. WHAT PERSONAL DATA DO WE COLLECT?

We only collect Personal Data that is adequate, relevant and limited to what is necessary for the purposes described below. Your Personal Data are generally collected directly from you. When some of your Personal Data are necessary for us to consider your application, we will indicate this at the time of collection (generally by an asterisk).

Your Personal Data may also be communicated to us by third parties, based on information you have provided to us in your application (former employers mentioned as references, profile data from social networks you have mentioned in your application, etc.). The categories of Personal Data that we collect indirectly are therefore limited to data relating to your education and skills, your past experiences and any information about your background or profile related to your application.

4. WHAT ARE THE PURPOSES OF COLLECTING YOUR PERSONAL DATA AND HOW LONG ARE THEY STORED?

At the end of these periods, certain Personal Data may be archived with restricted access for a period not exceeding statutory periods of limitation or for the duration of proceedings for evidentiary purposes, after which they will be destroyed.

5. TRANSFERS OUTSIDE THE EUROPEAN ECONOMIC AREA

Your Personal Data may be made accessible to subsidiaries of the Relais & Châteaux group located in the United Kingdom and in the United States, as well as Properties (a list of which can be consulted at https://www.relaischateaux.com/fr/site-map/etablissements) which may be located outside Europe, in countries recognised by the European authorities as having an adequate level of Personal Data protection (such as the United Kingdom), but also in countries that do not have such recognition (such as the United States). These Personal Data transfers are carried out in order to review your application and are also necessary for the implementation of pre-contractual measures taken at your request (your application with a view to signing an employment contract) in accordance with Article 49.1.b) of the GDPR.

6. YOUR RIGHTS

We remind you that you have the right to request access to your personal data and rectification of incorrect data concerning you and, in the cases provided for in the regulations, the right to object to processing, to obtain the erasure of certain Personal Data, to limit their use or to request their portability for transfer to a third party, to withdraw your consent (if certain Processing is based on your consent), and also, if you reside in France, to define directives for the post-mortem Processing of your Personal Data.

If we are unable to identify you with certainty, for security reasons, you will be required to submit a copy of an identity document with your request. You will be contacted within a maximum of one month from the date on which your request is received.

In addition, you are reminded that, in accordance with the regulations, some requests concerning certain rights may be refused (in particular the erasure of Personal Data) for legitimate reasons such as the defence of legal claims.

You also have the right to lodge a complaint with a competent supervisory authority, which is the Commission Nationale de l'Informatique et des Libertés (CNIL) in France.
